

U.S. EPA EVAPORATIVE EMISSION CONTROL WARRANTY STATEMENT

YOUR WARRANTY RIGHTS AND OBLIGATIONS

The U.S. Environmental Protection Agency (EPA) and Great Northern Distributing, Inc. are pleased to explain the Evaporative Emission Control System (EECS) warranty on your 2025 Small Off-Road Equipment (SOE). Great Northern Distributing, Inc. must warrant the Equipment Evaporative Components (EEC) on your SOE for the period listed below provided there has been no abuse, neglect or improper maintenance of your EEC leading to the failure of the EECS.

Your EECS may include parts such as the carburetor, fuel tanks, fuel lines (for liquid fuel and fuel vapors), fuel caps, valves, canisters, filters, clamps, connectors, and other associated components.

Where a warrantable condition exists, Great Northern Distributing, Inc. will repair your EEC related part that may include fuel tanks, fuel lines (for liquid and fuel vapors), fuel caps, fuel fittings and related components at no cost to you including diagnosis, parts and labor.

Please refer to the engine manufactures EECS warranty statement for applicable warranty coverage for the remaining EECS associated components.

MANUFACTURER'S WARRANTY COVERAGE:

This evaporative emission control system is warranted for two years. If any EEC related part on your equipment is defective, the part will be repaired or replaced by Great Northern Distributing, Inc.

OWNER'S WARRANTY RESPONSIBILITIES:

As the SOE owner, you are responsible for performance of the required maintenance listed in your owner's manuals. Great Northern Distributing, Inc. recommends that you retain all receipts covering maintenance on your SOE, but Great Northern Distributing, Inc. cannot deny warranty coverage solely for the lack of receipts or your failure to ensure performance of all scheduled maintenance.

As the SOE owner, you should be aware that Great Northern Distributing, Inc. may deny you warranty coverage if your EEC or related parts have failed due to abuse, neglect, or improper maintenance or unapproved modifications.

You are responsible for presenting your SOE to Great Northern Distributing, Inc. service center as soon as the problem exists. The warranty repairs shall be completed in a reasonable amount of time, not to exceed 30 days.

GENERAL EMISSIONS WARRANTY COVERAGE:

Great Northern Distributing, Inc. warrants to the ultimate purchaser and each subsequent purchaser that the SOE is:

Designed, built and equipped so as to conform with all applicable regulations; and

Free from defects in materials and workmanship that cause the failure of a warranted part to be identical in all material respects to that part as described in the Great Northern Distributing, Inc. application for certification.

The warranty period begins on the date the SOE is delivered to an ultimate purchaser. The warranty period is two years.

Subject to certain conditions and exclusions as stated below, the warranty on EEC related parts is as follows:

(1) Any warranted part that is not scheduled for replacement as required maintenance in the written instructions supplied, is warranted for the warranty period stated above. If the part fails during the period of warranty coverage,

the part will be repaired or replaced by Great Northern Distributing, Inc. according to subsection (4) below. Any such part repaired or replaced under warranty will be warranted for the remainder of the period.

(2) Any warranted part that is scheduled only for regular inspection in the written instructions supplied is warranted for the warranty period stated above. Any such part repaired or replaced under warranty will be warranted for the remaining warranty period.

(3) Any warranted part that is scheduled for replacement as required maintenance in the written instructions supplied is warranted for the period of time before the first scheduled replacement date for that part. If the part fails before the first scheduled replacement, the part will be repaired or replaced by Great Northern Distributing, Inc. according to subsection (4) below. Any such part repaired or replaced under warranty will be warranted for the remainder of the period prior to the first scheduled replacement point for the part.

(4) Repair or replacement of any warranted part under the warranty provisions herein must be performed at a service center at no charge to the owner.

(5) Notwithstanding the provisions herein, warranty services or repairs will be provided at all of our distribution centers that are franchised to service the subject engines or equipment.

(6) The SOE owner will not be charged for diagnostic labor that is directly associated with diagnosis of a defective, EEC related warranted part, provided that such diagnostic work is performed at a warranty station.

(7) Throughout the SOE warranty period stated above, Great Northern Distributing, Inc. will maintain a supply of warranted EEC parts sufficient to meet the expected demand for such parts and must obtain additional parts if that supply is exhausted.

(8) Any replacement parts that do not increase the exhaust or evaporative emissions of the engine or EECS must be used in the performance of any warranty maintenance or repairs and must be provided without charge to the owner. Such use will not reduce the warranty obligations of Great Northern Distributing, Inc.

(9) Add-on or modified parts that are not exempted by the U.S. EPA may not be used. The use of any non-exempted add-on or modified parts by the ultimate purchaser may be grounds for disallowing a warranty claims. Great Northern Distributing, Inc. will not be liable to warrant failures of warranted parts caused by the use of a non-exempted add-on or modified part.

(10) Great Northern Distributing, Inc. shall provide any documents that describe their manufacture's warranty procedure or policies within five working days of request by U.S. EPA.

EMISSION WARRANTY PARTS LIST FOR EEC:

The repair or replacement of any warranted part otherwise eligible for warranty coverage may be excluded from such warranty coverage if Great Northern Distributing, Inc. demonstrates that the SOE has been abused, neglected, or improperly maintained, and that such abuse, neglect, or improper maintenance was the direct cause of the need for repair or replacement of the part. That notwithstanding, any adjustment of a component that has a factory installed, and properly operating, adjustment limiting device is still eligible for warranty coverage. The following emission warranty parts list are covered:

- (1) Fuel Tank
- (2) Fuel Cap
- (3) Fuel Lines (for liquid fuel and fuel vapors)
- (4) Fuel Line Fittings
- (5) Clamps*
